1. Agreement

By providing your mobile phone number and opting in to receive SMS conversational messages from Walk In GYN Care Professional ("we," "us," or "our"), you agree to these SMS Terms & Conditions.

2. SMS Messaging Program

Our SMS conversational messaging program provides convenient communications related to your care and our services.

You may receive text messages regarding:

- Appointment reminders
- Appointment confirmations
- Appointment scheduling and rescheduling
- Billing notifications
- Information related to your care
- Responses to messages you send to our office
- Other important communications regarding our services

SMS messages are intended for administrative and patient care communications. They are not intended for medical emergencies. If you are experiencing a medical emergency, call **911** immediately.

3. How to Opt In

By providing your mobile number and opting in to SMS from **WALK IN GYN CARE PROFESSIONAL**, you agree to receive **customer care messages**. You may opt in to receive SMS messages by sending keyword "JOIN", you can also:

- Completing an online form and providing consent.
- Providing verbal consent during a phone call.
- Providing verbal consent while speaking with our staff in person.
- Providing your mobile phone number and requesting SMS communications.
- Initiating a text conversation with our office and continuing SMS communications after receiving information about our messaging program.

By opting in, you confirm that you are the authorized user of the mobile phone number provided.

4. Message Frequency

Message frequency can vary depending on your appointments, requests, and communications with our office. On average, 1-2 messages per month.

5. Message and Data Rates

Message and data rates may apply according to your wireless carrier's messaging plan.

6. Opting Out

You may opt out of receiving SMS messages at any time by replying **STOP** to any message.

After opting out, you will no longer receive SMS communications unless you choose to opt in again.
